- Advertising and Marketing (Promotional) Expenses

 - Actual Car Expenses include payments, depreciation, registration, insurance, garage rent, licenses, repairs and maintenance, and parking and toll fees
 - Standard Mileage Expenses keep a log, daily, weekly or monthly, of miles driven to distinguish personal use from business use
- Travel Expenses, such as air, bus, or train fares.
- Depreciation Car bill of sale; Date when initially put to business use
- Health Insurance Premiums (Income Credit instead of Tax Deduction)
- Office Supplies
- Office Rent or Home Office Expenses (provide electricity bill if used for all 12 months)
